D) Physical development works:

Subject 1): For Newly approved Science Faculty from Academic Session 2016 -17, regarding construction of new laboratory for Botany on top of Chemistry Laboratory for B.Sc. Science.

Resolution 1): New Faculty of B. Sc. Science Part 1 has been approved from the session 2016 -17 and keeping in mind the interest of the students, there is a shortage of Botany laboratory in the college. It is necessary to build a Botany laboratory on the top of the Chemistry laboratory in the college.

Subject 2): Regarding the proposal for construction of security wall of the college from the grant received from Hon'ble District Sports Officer Amravati

Resolution 2): -A proposal has been prepared in this regard of building a security wall of the college from the reserve fund of the Honorable District Sports Officer Amravati and all the necessary documents have been completed by the college. There is a provision to spend a 80% of the amount from the District Sports Officer and 20 % of the organization's share for the said construction. If the proposal is approved by the District Sports Officer, the proposed construction will be done.

Subject 3): Regarding renovation of the office in the college.

Resolution 3): As the college has only one room for the administrative office, it is necessary to renovate the office as it creates difficulty for the staff to work.

Subject 4): Regarding obtaining permission for the construction of a platform and a box tiles in front of it for conducting college programs in the open space in front of the college.

Resolution 4): - For conducting educational and other programs in the open space in front of the office, a platform is necessary and tiles should be installed in front of it.

Subject 5): Regarding permission for construction of two separate toilets for boys and girls on the first floor of the college

Resolution 51: The College has separate toilets for boys and girls on the ground floor and the students lectures are organized on the upper floor, so it is necessary to construct a toilet on the upper floor.

Subject 6): Regarding permission to construct new classrooms for B.Com. in English medium of Commerce Faculty from next session 2018-19 next to Physics Laboratory

Resolution 6): In the session 2018 -19 the college is likely to get the new student branch B.Com. 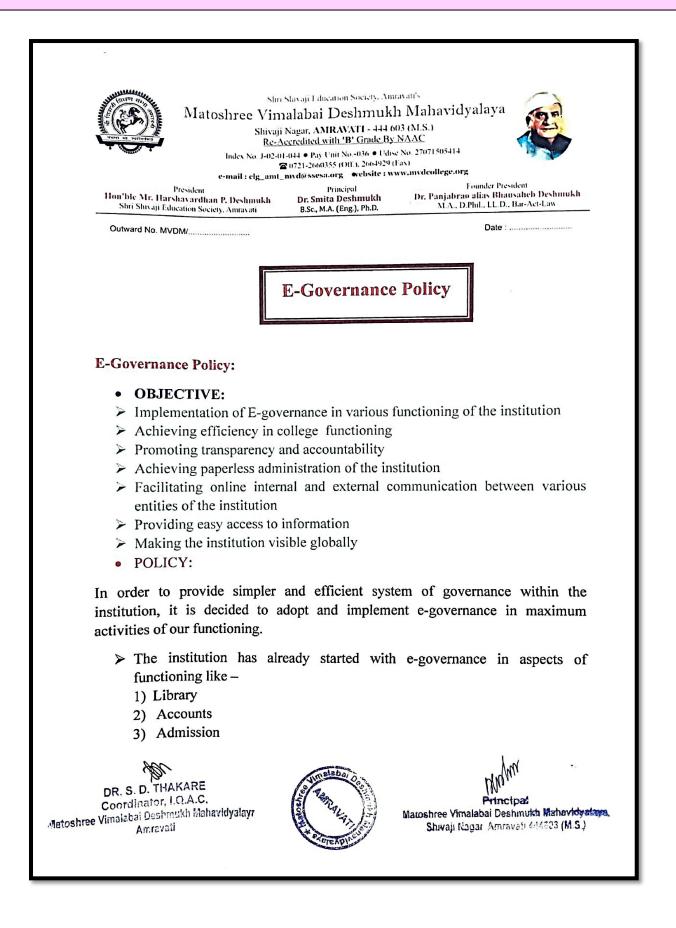

For convenience purposes, the policy is divided into various areas of operation. These areas of operation are illustrative and the institute reserves the right to implement e-governance even in the areas not enlisted herewith.

1. WEBSITE:

The website acts as a mirror of the college activities and information about all activities are made easily available to the outsiders. For this purpose, website committee has been design by the Principal. Existing staff and persons have been identified to undertake the responsibility of website administration and updating the website at the college level.

2. STUDENT ADMISSION:

The College has decided to process the admissions in online mode. This will cover admissions to all graduate courses. The Principal is given the authority to take appropriate decisions and identify the persons responsible for implementation of this aspect of the policy.

3. ACCOUNTS:

For ease of maintaining accounts, the Institute can use ERP software. Appropriate security measures should be taken for maintaining confidentiality of the transactions. Training to the existing staff and updating of the existing software's must be done on timely basis.

The Library is fully automated with e – granthalay software for data feeding, bar coding.
